

# PMOD Cloud License Introductory Promotion

(November 1, 2020 - February 28, 2021)

The lockdown situation in the past few months has painfully uncovered the drawbacks of node-locked software licenses. To back our customers up, we provided a free 3-month license over the Internet to anybody who could not access their regular license. Very positive feedback and a general demand for more flexible licensing led us to develop a cloud licensing solution.

PMOD cloud licensing allows the user to work with a local PMOD installation whenever an Internet connection is available. With the advent of PMOD's annual version 4.2, cloud licensing is offered as a 4th license type, alongside the proven standalone, network, and audit trail types.

During the 4-month period following the launch of v4.2 (Nov. 1, 2020 – Feb. 28, 2021; 90-day validity of quotes), an **introductory discount of 20%** will be granted.

## PMOD Cloud Licensing in a Nutshell

- A cloud license comprises a pool of clients (single licenses) managed by a PMOD-operated license server in the cloud. Thus, the users are relieved from setting up a server infrastructure of their own.
- Analysis is performed locally, and no image data is transferred to the server.
- Arbitrary machines (clients) can start their local PMOD installation and use the cloud license, if Internet access to the cloud license server is available and the unique Client ID of the license is known.
- Cloud licenses require a Cloud License Agreement which details 24/7 access and which comprises annual subscription at a flat rate. When acquiring a cloud license, the subscription to the agreement is included, that is, the flat rate is waived as long as the license is in the latest annual version.
- A cloud license may be converted into a (perpetual) network license free of charge in case a customer wishes to cancel the cloud license subscription.
- Before acquiring a cloud license, please validate operation via a 30-day trial installation, as changes of firewall settings and alike may be required.

## Migration of Existing Licenses to Cloud Licensing

Existing PMOD licenses, of standalone or network type, and in any version, may be migrated to cloud licensing. During promotion time, the cloud licenses are offered at the 20% introductory account. Moreover, your existing licenses may be **traded in at the privileged terms of PMOD's parallel campaign, the "PMOD Upgrade Promotion v4.2"**.

## Start Your Maintenance Agreement

PMOD's maintenance agreements (support service agreements) are aimed at customers wishing to work always with the most recent PMOD version and to benefit from privileged support and training. The agreements comprise the annual version upgrade together with intermediate maintenance builds at a privileged rate (20% for academic, 25% for commercial customers, instead of the regular 30%) and include a list of further services.

A cloud license agreement may be fully integrated into a maintenance agreement, with the bonus that the **annual flat rate will be waived**.
